1. GENERAL SUMMARY OF RESPONSIBILITIES:

Apply paint to blasted parts using an electrostatic spray gun. Manually run the abrasive blaster to remove any mill scale, dirt, and rust to create a blast profile for better application of paint. Work is planned and supervised by Paint Lead.

2. SPECIFIC JOB RESPONSIBILITIES:

- A. Identify the part that is to be painted, find the correct job packet, and record correct quantities.
- B. Apply caps and plugs to parts to protect from media blasting and painting.
- C. Perform daily inspection of fresh air hood or respirator.
- D. Perform normal grinding, buffing, and other surface preparation activities prior to paint application.
- E. Change and adjust nozzles, valves, paint guns, regulates flow of air, paint, and/or voltage levels for paint material application.
- F. Inspect blasted parts for missing welds and painted parts for runs, sags, and unpainted areas.
- G. Lubricate, check and/or clean equipment and tools.
- H. Maintain supply of paint and media. Keep track of equipment and accessories needed.
- I. Change paint booth lights regularly and keep paint booth clean and free from obstructions.

3. JOB SPECIFICATIONS:

- A. Education/License/Certification Requirements
 - 1. High School diploma or equivalent, preferred.
 - 2. Forklift operator's license, required. Training and licensing can be administered by Company Safety Coordinator.

B. Experience Requirements

- 1. Knowledge of, and experience with, various shop tools, required.
- 2. Basic mechanical ability required.
- 3. One-year machinery painting experience, required.

C. Physical Requirements

This position will involve that physical exertion found in a metal fabrication company making agricultural equipment and will include stooping, climbing, lifting and other such exertion necessary to become and remain familiar with plant type work.

- 1. Ability to walk and stand for long periods of time, throughout the work day, required.
- 2. Ability to stoop, bend and/or reach overhead occasionally during the day may be required.
- 3. Ability to kneel or crawl occasionally during the day may be required.
- 4. Ability to climb and balance occasionally during the day may be required.
- 5. Manual dexterity, required.
- 6. Wear personal protective equipment; fresh air breathing apparatus, protective suit, proper footwear, gloves and hearing protection, required.

D. Lift and Carry Requirements

 - b. Carrying raw materials short distances, up to 10 feet.
- 2. This position requires frequent lifting and carrying of machine parts, weighing over 70 lbs. using hoists or forklift or hand truck.

E. Equipment/Tools Requirements

- 1. Ability to utilize forklift, hoists or hand truck, required.
- 2. Ability to utilize tools such as hand drill, air wrench, metal grinder, etc., required.
- 3. Ability to use an electrostatic paint gun and manual abrasive blaster, required.

F. Environment Requirements
